 applies also for change of in-house to subcontractors or change of subcontractor for essential operations as e.g. heat
 treatment, etc.
- 6. Weld repair is not acceptable.
- 7. Destructive & Non Destructive testing shall be as per the respective Material Data Sheets of NORSOK M-630 Ed. 6.
- NDT operator qualification shall be as per EN 473 / NS-EN ISO 9712 equivalent based on the purchaser's requirements.
- A temperature uniformity survey for the heat treatment furnaces shall be carried out annually in accordance with API Spec 6A:2010 / ISO 10423:2009 Annex M, ASTM A 991 or equivalent and additional requirements of NORSOK M-650 Ed. 4 Annex B.
- 10. This certificate is issued after satisfactory completion of qualification as per NORSOK M-650 and NORSOK M-630.
